Mayor Bass-Prieto opens the floor for public comments on Ordinance 1144-2023.

Rolanda Jackson, no address provided.

- Stated that customer service has taken a different approach since Latrenda Gainous took over.
- Stated that she is not popular or trying to be popular in the city.
- Stated that there is an ordinance that citizens pay their utilities bill.
- Stated that she could not find the customer service department in the budget.
- Requested the arrears report for businesses and residential.
- Stated horns get tooted for who we want to toot horns for. Customer Service is the main driving force that drives the city's revenue.
- Stated that other departments where no one is being supervised make more money than the customer service supervisor.
- Stated that you get what you pay for, and we are getting more with Ms.
 Gainous Carroll, than purchasing. You get three bids and select the lowest.
- Stated that there are no savings in purchasing, whereas you catch the devil in the customer service department.
- Stated that Commissioners control what they need to control and for citizens not to pay utilities bills is on the dais.
- Asked the city manager when will the utilities ordinance be enforced.

City Manager Nixon stated that there is a process and formula used by HR to determine salaries.

City Manager Nixon stated that it is very difficult to compare departments to departments.

City Manager Nixon stated that evidence shows that the city did not adhere to the purchasing policy and the bid process was flawed and in many cases friends benefited.

City Manager Nixon stated that the city never used coordinated buying mechanism.

City Manager Nixon stated that when he took over as city manager, he evaluated every staff member and recognized that the customer service person has great skills in building rapport with customers and leadership abilities.

City Manager Nixon stated that he is proud to say that customer service has done extremely well and has received compliments.

City Manager Nixon stated that the bread and butter is the utilities department and therefore customer service and the utilities department will merge because it makes sense since these departments work closely.

City Manager Nixon stated that the city does disconnections.

City Manager Nixon stated that the commission has allowed staff to create payment agreements with customers that are appropriate.

City Manager Nixon stated that the customer service supervisor revised that payment agreement policy to be straight forward.

City Manager Nixon stated that the no cash policy has reduced the city's liability, amount of time to balance the drawer which allows for more accuracy.

City Manager Nixon stated that the citizens will be dealt with care and know the rules.

City Manager Nixon stated that the right people are in the right place and soon the right structure will be implemented.

City Manager Nixon stated that all employees are paid according to the right standard.

City Manager Nixon stated that he will argue that employees need more money.

- Stated that citizens' final consultation regarding solar panels should be made with the city's utilities department.

- Recognized National Hispanic Heritage Month.
- Reminded everyone that racism is real. Spoke of the incident in Jacksonville, FL where innocent African Americans were killed.
- Stated that she is fearful of racism and hate and that this same evil can happen in the City of Quincy.
- Reminded us of 911 terrorist attacks.
- Stated that defamation of character is real and define as an intentional false statement causing the victim harm.
- Stated that the first amendment of speech does not protect individuals that participate in defaming another's character.
- Stated that performance evaluations are on staff.
- Stated that the vision workshop held in June, no documents have been given.
- Stated that the Quincy logo used by the arts center needs updating.

Mayor Pro-Tem Sapp

- Asked if the water line at Live Oak and Cooper been replaced.
- Stated that the cemetery near First Elizabeth needs cleaning.
- Reported that there are nails sticking up at the MLK railroad.
- Reported a trailer at Cooper Street on a vacant lot having a lot of construction materials on it.
- Asked permission to meet with the public works director regarding the Gadsden Technical College sign needed replacing.
- Suggested that the citywide clean up flyer be placed in a utility's mailer.
- Suggested that the music being played on floats reflects the holiday season.
- Charged the mayor in getting the materials to do the evaluations for the city manager and city clerk.
- Stated to citizens to please get with her on any budget suggestions.
- Stated that her goal is to do what's best for the City of Quincy.

Commissioner Harris

- Suggested scheduling a ride along with the city manager.
- Stated that the budget process was different.
- Stated that staff did the job by providing a balanced budget.
- Stated that the reality is the City of Quincy is maintaining.
- Stated that the city is seeing some positive results.
- Stated that the commission must have hard conversations about generating more revenue to provide the 4 million dollars that staff requested.
- Stated that investing in FLCLASS was a great investment.

- Reminded everyone of the mayor pro-tem comments that we're doing the best we can.
- Reminded everyone of the non-recurring dollars that came in and are no longer available.
- Thanked staff and Amanda Matthews for the hard work being done.
- Stated that Ms. Matthews has proven herself to be very knowledgeable in the field of finance.

Commissioner Wood

- Thank everyone involved in the budget process.
- Stated that she realized that the budget process is tendinous.
- Reiterated the need to reduce lawsuits.
- Reminded the constituents of district one that the budget process continues, and changes can be made.
- Stated that this is a good starting point after going through the process.
- Stated how much she appreciates the city manager and department heads for listening to the citizens.
- Stated that there is a must to keep the city safe and not compromise everything.
- Stated that she would love to give staff everything, but the need is to be strategic in our approach.
- Working on the revenue streams is paramount.
- Stated that contractors must be held accountable.
- Stated that we must feel safe in our community.
- Stated how much she appreciates what her constituents are doing.
- Reminded citizens that the budget is available, and anyone can receive copies.
- Stated that citizens can make budget recommendations.
- Stated that the commission is attempting to make the city fiscally sound.
- Recognized Hispanic Heritage Month, Blood Cancer Awareness, and Patriots Day and National Suicide Prevention as well as Alzheimer's Month.
- Quoted Helen Keller: "Alone we can do so little; together we can do so much"

Mayor Bass-Prieto

- Complimented Amanda Matthews on her knowledge of the budget and how she answers questions.
- Concern about the litter picking up.
- Concern about the number of cars speeding along King Street.
- Thanked the customer service supervisor regarding heading up the Christmas chorus.
- Thank you to the city manager for delivering a conservative budget.
- Stated that all should learn from the past and not repeat it.
- Stated that is a need to grow.
- Stated that the commission will look at the budget and where employee raises can be given.
