Tom Lewis, no address provided, made the following comments:

- Stated that he is the CFO and a board member of the Big Bend Community Development Corp.
- Stated that the BBCDC started over 20 years ago in Tallahassee.
- Stated that the BBCDC has built over 150 affordable houses.
- Stated that in May the BBCDC moved its head office to 16 N. Adams Street, Quincy, FL.
- Stated that one of its tenants makes unbelievable pound cakes.
- Stated that the space in the bakery was made larger to add Q-Dogs and Cream.
- Stated that the grand opening of Q-Dogs and Cream is next Friday, at 4 pm.
- Stated that there are hopes of opening a Black History Museum, in the City of Quincy.

#### Summary of the Discussion by Staff and the Commission

Captain Monroe stated that the request is for a temporary closure of highway 90.

City Manager Nixon stated that FDOT has permitted the temporary closing of highway 90.

City Manager Nixon stated that this is a formality to bring the request to the Commission.

Captain Monroe stated that the detour route has been preapproved pending the approval of the resolution by the Commission.

#### Agenda Item #5 Update on Plan to Complete the Fiber Optic Repair

#### Summary of the Discussion by Staff and the Commission

Utilities Director Ash stated that in 2018 Hurricane Michael's landfall devastated the City's fiber optic system.

Utilities Director Ash stated that work on the fiber system began but stopped.

Utilities Director Ash stated that all the work on the fiber system was done before his employment with the city.

Utilities Director Ash stated that the staff is committed to finishing the work by April 2023.

Utilities Director Ash stated that a lot was damaged, and materials were purchased by the contractor.

Utilities Director Ash stated that repairing the fiber optic system is time sensitive to receive FEMA reimbursements.

Utilities Director Ash stated that the fiber optic system can open the way to modernize the City's phone system, traffic signals, cameras, and electric substations adding security, functionality, and information access.

Utilities Director Ash provided a list of items that needed to be completed to operationalize the fiber optic backbone.

Utilities Director Ash stated staff contacted Applied Comp-Tek and asked if they would comply with the old contract, build the system back, and meet the March 31, 2023 deadline.

Utilities Director Ash stated that Applied Comp-Tek agreed to the terms.

Commissioner Harris thanked the city manager for his direction in moving the project forward.

Commissioner Harris stated that he appreciates having someone in-house monitoring the project.

Utilities Director Ash stated that the goal is to read meters automatically.

City Manager Nixon thanked Utilities Director Ash for getting the project back on track.

City Manager Nixon noted that the mayor pro tem attended a workshop a few weeks ago and brought back grant information on applying for water meters.

Commissioner Sapp also applauded Utilities Director Ash on how he has embraced the job and the follow through.

#### Background:

For many years, the City of Quincy has supported community-based organizations which provide goods, services, and programs as a means of addressing quality-of-life challenges impacting residents. The Quincy City Commission approved a budget for the fiscal year 2022-2023 which included funding to provide financial aid to Non-Profit Organizations located in the City serving its residents.

#### Statement of Issue:

During this year's budget cycle, the City Commission heard presentations and received requests for funding from several non-profit organizations.

During a special meeting on October 25, 2022, the commission voted to fund several non-profit organizations up to \$10,000.

Although a request was submitted for funding, Tau Zeta Graduate Chapter was not properly notified of a meeting date.

Tau Zeta Graduate Chapter was organized on May 26, 1956, with nine chartered members in Quincy, Florida, and engages in several recurring events throughout the City of Quincy, specifically tailored to women, youth, seniors, and men.

The Tau Zeta Chapter of Zeta Phi Beta Sorority, Inc. which was organized May 26, 1956 with nine chartered members in Quincy, Florida. We are a non-profit 501(c)3 community conscious action-oriented organization. We stand on our principles Scholarship, Service, Sisterhood and Finer Womanhood. I would like to take a moment and go over a few of our local and national program and services.

- Our local Tau Zeta Chapter organization introduced our youth program 2/23/1969 in Gadsden County that service ages 11 to 18. We teach live skills, mentor, self-empowerment, promote scholarship, interview skills, etc.
- Our local Tau Zeta Chapter purchased our Sorority House in city limits district one,
  June 1994, where we have our chapter and auxiliary meetings, and we house our Stork's Nest in
  partnership with March of Dimes.
- Our local Tau Zeta Chapter adopts schools in Gadsden County to provide services: warm clothing drive, teacher supply drive, scholarships, feeding the hungry, helping the homeless student population etc.
- Elder Care Initiative is one of our National Programs-supporting the caregiver and volunteering at senior care facilities.
- Stork's Nest is one of our National Programs-This program is designed to promote
  prenatal care participation and encourage healthy behaviors during pregnancy through two
  components-incentives and education. This program allows us to reach other municipalities as
