**COMMENTS FROM THE AUDIENCE**

Rolanda Jackson, FL 2480 Bainbridge Hwy, Quincy, FL, made the following comments.

- Stated that she has the privilege of working with some children.
- Stated that we need to start working on a summer camp for our young people.
- Stated that last Thursday she went to the courthouse and there were 88 juveniles with cases on the docket.
- Stated that many of the juveniles were being taken into custody.
- Stated the pool never ready.
- Encourage the commission to work with the city manager.
- Stated that spring break is next week.
- Stated that the kids need something to do.
- Stated that she is willing to assist.

Daphne Brown, 405 Strong Rd., Quincy, FL made the following comments.

- Stated that she has 6 children, 5 are solely dependent on her.
- Stated to the commission let's be honest people.
- Stated that the Asst. Police Chief on October 17 was the supervisor over dispatch.
- Stated that hiring an attorney is easier said than done especially in her current tax bracket.
- Stated that she was told that as a dispatcher she was unable to join the union.
- Stated she was expected to complete her probation.
- Stated that the commission should investigate policy and procedures.

Mayor Pro-Tem Sapp stated that when a lawsuit is filed, the lawsuit is covered by the Florida League of Cities or insurance.



- Stated that the city attorney job is to look into issues brought up.

Mayor Pro-Tem Sapp asked Ms. Brown if she'd spoken with the city manager.

- Stated that she met with the city manager and expected him to provide guidance.
- Stated that her issue is not with day-to-day but with policies and procedures.
- Stated that she explained her position of what was going on.
- Stated that that there has been no resolution.

Mayor Pro-Tem Sapp stated that Ms. Brown has been before the commission twice and clarity is needed, especially a mother who is frustrated and trying to support six children.

Henry Gunn Jr., 717 Glades Rd. Havana, FL, made the following comments.

- Stated that he was before the commission two weeks ago.
- Stated that he does not live in the City of Quincy.
- Stated that he went home and watched the meeting on tv.
- Thanked Mayor Pro-Tem Sapp and Commissioner Wood for responding to his comments.
- Stated that he was disappointed with Commissioner Harris and the city manager taking sides with the police officer.
- Stated that he had four run ins with the acting police chief.
- Stated that he knew after speaking with the acting police chief that he was not capable of holding up to the constitution he had sworn to protect, because of his intellect.
- Stated that he told the acting police chief he had 18 months to find him a new job because this is not the city for him.
- Pointing to Commissioner Harris, Mr. Gunn stated that his election is coming up and to the city manager he stated that his butt is on the hot seat.
- Stated to fix it or he will get out on the campaign trail and Commissioner Harris and the city manager will have to find a new job.
- Stated that he had a motorcycle accident just pass Maryland's Chicken.
- Stated that a fellow motorcyclists had an accident and died.
- Stated that there is a need to do something about that area and suggested placing flashing lights to let drivers know to reduce their speed.
- Stated that it is the state's responsibility to fix the safety issue in this area.

Mayor Bass-Prieto stated that she contacted the DOT regarding conducting a traffic study in that area and was informed that a traffic study had already be completed and the study concluded that the speed limit was sufficient.

Mayor Bass-Prieto stated that she would be happy and sit down with Mr. Gunn to review the study and work together to get the speed reduced.

- Stated that something needs to be done now before another death occurs.
- Stated to Commission that he would be back in two weeks.



Mayor Pro-Tem Sapp asked the city attorney if there were any laws and statutes available to help fight this battle.

Commissioner Wood stated that in Leon County there are signs noting road obstructions ahead and maybe the city can look into that.

**Summary of the Presentation and Discussion by Staff and the Commission**

**Agenda item #4 – Resolution 1457-2024**

City Attorney Roberts read resolution 1457-2024.

City Attorney Roberts stated that the resolution was drafted to conclude the 2.15.

City Attorney Roberts stated that he would like the commission to review the resolution and determine if the content is sufficient.

Commissioner Nash asked if the commission is voting on the resolution or providing corrections.

City Attorney Roberts stated that whatever is the will of the commission.

Commissioner Nash stated that she had submitted her corrections to the city attorney which are reflected in the document.

Commissioner Nash stated that she voted against ending the 2.15 investigation because she saw and heard things that were disturbing and should be brought.

Commissioner Nash stated that she would be voting no on Resolution 1457-2024.

Commissioner Nash reiterated that she is not in compliance with ending the 2.15 investigation.

Commissioner Harris stated that the resolution reflects what took place with the 2.15 Investigation.

Commissioner Nash stated that the truth was left out of the resolution and therefore if the truth is left out, she would not support the summary resolution.

Commissioner Nash stated that she must vote her conscience as to what the resolution means.

Commissioner Harris asked Commissioner Nash if she provided her edits to the dais.

Commissioner Nash stated that her edits were given to the city attorney.

Commissioner Harris noted that the city attorney cannot determine what goes into the resolution.

Commissioner Harris stated that he could not vote on Commissioner Nash's edits that were given to the city attorney and not the dais.

Commissioner Nash stated that the edits were requested by the city attorney and not the dais.

Commissioner Nash suggested that the original resolution be brought back in front of the dais.

Mayor Bass-Prieto stated that the resolution came before the commission and was tabled so that the commission could provide the edits.

Mayor Bass-Prieto stated that she had only one concern regarding the resolution.

Commissioner Harris stated that he had a concern but nothing major, such as noted that the resolution should reflect that there is a transcript of the proceedings should someone wants to get a copy of it.

City Attorney Roberts stated that the transcript can be included in the transcript.

Mayor Pro-Tem Sapp stated that she is pleased to see that the resolution reflects that documents provided during the 2.15 investigation were turned over to FDLE.

Commissioner Wood stated that although she was not on the prevailing side and wanted to continue the investigation, she really doesn't like the word justified used in #2. Commissioner Wood suggested utilizing another word.

City Attorney Roberts proposed replacing the word justified with support.

Commissioner Wood asked the city attorney to clarify what she would be voting on.



City Attorney Roberts stated that the vote would be on conclusion of the investigation and since there is not a formal document concluding the formal proceedings, the resolution concludes the 2.15 investigation proceedings in a resolution format.

City Attorney Roberts stated that the city had never participated in a 2.15 investigation hearing that concluded with a resolution.

City Attorney Roberts stated that the commission requested some type of documentation, and a resolution will do just that.

Commissioner Harris reminded the commission that the resolution is a part of the 2.15 procedures received by the commission.

Commissioner Harris suggested to replace the word justified with “documentation supporting the city manager’s decision to terminate Chief of Police Timothy Ashley.”

Commissioner Wood stated that this is where she’s going, she would like the statement to be more specific as the termination was the city manager’s decision.

Mayor Bass-Prieto asked for a motion to table Resolution 1457-2024.

Commissioner Harris offered a motion to table resolution 1457-2024.

Mayor Pro-Tem Sapp seconded the motion.

**Summary of the Presentation and Discussion by Staff and the Commission**

**Agenda item #5 – Due Diligence Operating Agreement**

Mrs. Davis thanked the commission for allowing her to speak on the city’s solar array field.

Mrs. Davis introduced her partners Dr. David Moye and David Arnold.

Mrs. Davis stated that her focused is to assist rural communities addressed renewable energy goals and objections.

Mrs. Davis stated that Gadsden Renewables met with the city manager and the utilities director on several occasions.

Mrs. Davis stated that based on surveys and communications with the city manager and utilities director, Gadsden Renewables believes that it can be of service to the City of Quincy.

Mrs. Davis stated that Gadsden Renewables has experience in this area.

Mrs. Davis stated that additional information is necessary for Gadsden Renewables to determine the city's needs.

Mrs. Davis noted the bullet list given to the commission which references the benefits.

- Due Diligence performed by Gadsden Renewables has no cost or fiscal impact to the city.
- Renewable energy specialists will inspect all solar array data on the city's behalf.
- Gadsden Renewables will provide a punch list outlining the capacity.
- Gadsden Renewables will manage the array field on behalf of the city.
- Gadsden Renewables will obtain an energy \$2 million storage battery with a matching \$2 million.
- The City of Quincy will have a dedicated and experienced management team monitoring and maintaining its solar array field.
- The City of Quincy will have a dedicated renewable energy team with time and resources.
- Working to reduce the city's budget with a savings that could be utilized in other needed areas.

Mrs. Davis stated that Gadsden Renewables would like no more than six months to inspect the solar array field.

Mrs. Davis stated that once the inspection is completed Gadsden Renewables will meet with the city manager to present an agreement.

Commissioner Nash asked what the utilities director's comments were concerning the agreement.

Commissioner Nash stated that her concerns are.

- No overall plan vision for the solar array has been presented from the utilities director or the city manager.

Commissioner Nash stated that since there is not a plan, she is a bit disjointed.



Commissioner Nash stated that she had not seen any specifics as to what the savings would be.

Commissioner Nash noted that the city has a bid process not being utilized in terms of seeking out the landscape of those that could support the solar array field.

Commissioner Nash stated that she's concerned that this may or may not be premature.

City Manager Nixon stated that there was a tremendous process which concluded to install a solar field.

City Manager Nixon stated that there was a lot of effort and resources made to install a solar field.

City Manager Nixon stated that to determine how to move forward with the fiscal restraints it is necessary to understand our solar field which requires us to reach out to the experts.

City Manager Nixon stated that if one is to search for the number of experts in this field you would discover that there are not many in this area.

City Manager Nixon stated that the solar array field is not being compromised in anyway and any findings by Gadsden Renewables will be brought to the attention of the commission to address.

City Manager Nixon stated that the utilities director has been conservative on this issue.

Commissioner Wood reiterated for understanding that the due diligence findings would be brought back before the commission.

Commissioner Wood again stated for clarification that the due diligence is to bring back to the commission the findings.

City Manager Nixon stated that the due diligence is not a contract for anything further.

City Manager Nixon stated that staff would need to be involved in this process.

City Manager Nixon stated any repairs needed minor or major will be brought to the commission.

Commissioner Wood noted that any repair cost is the city's responsibilities.

Commissioner Wood asked for an explanation of what it means in the due diligence that Gadsden Renewables will manage the solar array field.

City Manager Nixon stated that the due diligence is the only thing in discussion at this time and more clarification is needed with the management statement in the due diligence.

City Manager Nixon stated that Gadsden Renewables can bring to the commission specifics functions.

Mayor Pro-Tem Sapp referenced her January notes as it related to Commissioner Nash's comments of putting the cart before the horse.

Mayor Pro-Tem Sapp stated that she remembers when the solar panels were installed, and the concept behind it.

Mayor Pro-Tem Sapp questioned why it wasn't known that the solar field needed to be monitored.

Mayor Pro-Tem Sapp stated that she is troubled by not seeing a cost associated with the agreement.

City Manager Nixon stated that Mrs. Davis indicated that the due diligence would be performed at no cost without fiscal impact on the city.

City Manager Nixon stated that the due diligence is for the commission and staff to understand what kind of condition the solar array is in.

Mrs. Davis stated that the due diligence performed at no cost is simply because the non-profit received a \$100,000 award to do the assessment.

City Manager Nixon stated that he could not locate any paperwork on the former company associated with the solar array.

Commissioner Harris wondered how much a study would cost the city if Gadsden Renewables was not offering its services to the city.

Dr. Moye of Gadsden Renewables stated that the cost would range from \$30,000 to \$150,000.

Commissioner Nash stated that the due diligence verses having a MOU causes her to pause.

Commissioner Nash stated that the flashing light is an operations management agreement.

Commissioner Nash stated that the operations management agreement speaks volume on another level in just an assessment.

Commissioner Nash stated that in roman numerical III, in the due diligence references that the operations management agreement becomes binding upon the parties unless the following has not occurred brings her to pause.



Commissioner Nash states that there are several concerns in the document which cause her to pause.

City Manager Nixon suggested that the commission schedule a workshop.

City Manager Nixon stated that it sounds as though the commission needs language in the document that addresses the commission's specific concerns but helps accomplish the goals.

City Manager Nixon suggested hosting a workshop this week because there are some grant opportunities coming up.

Commissioner Nash stated that she needs her utilities director to be totally involved in the process.

City Manager Nixon stated that this project would be under the utility's director purview.

Commissioner Nash stated that she needs the utility's director to agree with what's going on.

City Manager Nixon stated that staff will agree as long as this process does not compromise the integrity of the city's solar field.

City Manager Nixon suggested holding a workshop on Thursday.

Mayor Pro-Tem Sapp requested the city manager bring with him to the workshop historical data related to the solar field.

City Manager Nixon stated that the solar field was before his time as a city manager but will gladly bring to the workshop all documents in the city's possession.

City Manager Nixon stated that whatever time is convenient for the commission.

Commissioner Nash stated that she has a conflict Thursday.

Commissioner Wood stated that there are things which existed prior to some of the commissioners on the dais time, therefore when things are brought forth regarding existing items, it is important to supply the commission with all supporting available documents if an informed decision is expected.

Mrs. Davis requested a draft agreement from the commission on what is expected from Gadsden Renewables.

- Congratulations to the parks and recreation youth basketball champions. Stated how great it was to see the youth present in the chambers with their coaches and parents.
- Encourage participation in the parks and rec center and state that there is a lot going on there that one may not know.
- Thank you to everyone for speaking at today's meeting. Stated that comments are welcome and heard.
- Stated that as the commissioner for district one, your concerns are indeed my concerns.



- Stated that she is having a lot of complaints about the crime rate. Stated that crime has gone up. Stated that information has been given in the past about crime in the various neighborhoods.
- Stated that she could pull out a report or two since being a commissioner.

- Requested a follow up that Mr. Gunn spoke on, especially the three houses.
- Thank you to the city manager, city attorney and city clerk for responding to her in a timely manner.

#### Mayor Pro-Tem Sapp

- Stated to Commissioner Wood that the honeymoon is over.
- Asked the city manager to follow up on Mrs. Jackson's suggestion regarding the summer camp.
- Stated that next week starts Gadsden County's spring break.
- Stated that the children don't have anything to do, and we need to find something for them to do.
- Stated that she needs to see the police become more visible in her district.
- Stated that the hot spots are becoming hotter. Key and Clark Street. Request that the trash can in that area is removed because it serves no purpose.
- Stated that the traffic on Crawford St is horrible. One half of the road is blocked. Requested that the police department ride through the area to deter individuals from loitering, blocking traffic and smoking dope.
- Stated that we must get serious about our communities. We want to be safe.
- Stated that the traffic light at Stewart and Crawford Street is still not working.

Director Ash stated that the part was ordered, however it will not be available until next December.

- Stated that the wild hogs are out and to be careful not to sacrifice your life to save your pet.



- Stated that dispatchers should not tell callers how many officers are working and their whereabouts. It should be stated by the dispatchers that an officer will be with you.
- Stated that Tanyard creek is going to be live this weekend as well as PorchFest. There will be a lot for citizens to do.
- Requested that the area after the event is cleaned up and left in the original condition. Do not want to see trash along MLK and other areas.
- Stated that she reported a light out where Mr. Sanchez lives. He had a tree stuck by lighting because lines are running through a pine tree.

- Announced that PorchFest is on Saturday from 12 pm – 6 pm.
- Announced that today is equal payday for women. Honored Geraldine Mott for the many accomplishments made towards improving the lives of women.
- Wished everyone a Happy St. Patrick's Day.

City Manager Nixon acknowledged the Moye family who came to the meeting for the purpose of gaining insight into the city's government.

Dr. David Moye introduced his family to the commission.

The adjournment was motioned by Commissioner Harris and seconded by Commissioner Nash at 8:07pm.

**ORDINANCE NO. 1147-2024**

**AN ORDINANCE OF THE CITY OF QUINCY, FLORIDA PROVIDING FOR THE AMENDMENT OF CHAPTER 54, ARTICLE III, OF THE CODE OF ORDINANCES OF THE CITY QUINCY, FLORIDA, REGARDING TO THE CITY OF QUINCY MUNICIPAL POLICE OFFICERS' AND FIREFIGHTERS' RETIREMENT PLAN; AMENDING SECTION 54-59, TO IMPLEMENT THE CONCLUSIVE CANCER PRESUMPTION ESTABLISHED BY SECTION 112.1816, FLA. STAT., AND THE REBUTTABLE DISEASE PRESUMPTIONS UNDER SECTIONS 112.18, 112.181 AND 175.231, FLA. STAT.; BY AMENDING SECTION 54-59; AMENDING SECTION 54-61 TO EXTEND THE TERM OF SERVICE OF TRUSTEES FROM TWO TO FOUR YEARS; PROVIDING FOR THE REPEAL OF ANY ORDINANCE OR PARTS THEREOF IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Commission of the City of Quincy meet in regular sessions;

**WHEREAS**, the City Commission is authorized and empowered to amend the City of Quincy Municipal Police Officers' and Firefighters' Retirement Plan (the "Plan"); and

**WHEREAS**, the Florida Legislature has recognized that firefighters are in danger of elevated cancer risk and as a result created a conclusive duty related cancer presumption found in Section 112.1816, Fla. Stat.

**WHEREAS**, Section 112.1816, Fla. Stat. governs all Firefighter Pension Plans in Florida.

**WHEREAS**, the Legislature has further determined additional in-line of duty presumptions related to for hepatitis, meningitis and tuberculosis, hypertension and heart disease found in Sections 112.18, 112.181 and 175.231 applicable to both Firefighters and Police Officers.

**WHEREAS**, the City of Quincy desires to codify these presumptions as set forth in Statute in the Plan.

**NOTE:** ~~Struck through~~ language is language proposed to be deleted, Underlined language is amended language, and \*\*\* represents sections that have been skipped and that remain unchanged.



WHEREAS, the City of Quincy desires to amend the term of service for Trustees appointed to the Board from Two to Four years.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF QUINCY, FLORIDA:

**Section 1. Amendment of Section 54-59(d)(2)**

The City Commission hereby amends Section 54-59(d)(2) as follows:

**Sec. 54-59. - Basis, amount, and payment of retirement income.**

(d) *Disability retirement and retirement income.*

(2) *Disability retirement eligibility; in-line of duty presumptions.* A participant will be considered totally disabled if, in the opinion of the board of trustees, he is wholly prevented from rendering useful and efficient service as a firefighter or police officer; and a participant will be considered permanently disabled if, in the opinion of the board of trustees, he is likely to remain so disabled continuously and permanently.

- i. *Non-rebuttable conclusive cancer presumption.* The provisions of Section 112.1816, Fla. Stat. applicable to Firefighters are hereby codified within the Plan and are intended to be incorporated by reference as to Firefighters.
- ii. *Additional rebuttable presumption for hepatitis, meningitis and tuberculosis.* The presumption provided for in this subsection ii. shall apply only to those conditions described in this subsection (b) that are diagnosed on or after January 1, 1996.
- iii. *Rebuttable Presumption for hypertension and heart disease.* Any condition or impairment of health of a member caused by hypertension or heart disease shall be presumed to have been suffered in the line of duty unless the contrary is shown by competent evidence, provided that such members shall have successfully passed a physical examination upon entering into such service, including cardiogram, which examination failed to reveal any evidence of such condition; and provided further, that such presumption shall not apply to benefits payable or granted in a policy of life, insurance or disability insurance. The provisions of sections 112.18, 112.181 and 175.231, Fla. Stat., are here by codified within the Plan, and are intended to be incorporated by reference. The Board of Trustees may adopt uniform administrative rules for the conduct of hearings resulting and related to these rebuttable presumptions, and the determination of any disqualifying events reflected in Chapters 112 and 175, Fla. Stat.



**Section 2.     Amendment of Section 54-61**

**Sec. 54-61. Administration.**

- (a) *Administration by board of trustees.* There is hereby created a board of trustees of the City of Quincy Municipal Police Officers' and Firefighter's Retirement Trust. The board of trustees shall consist of five members, two of whom, unless otherwise prohibited by law, shall be legal residents of the municipality, who shall be appointed by the legislative body of the city and one member of the board shall be a police officer as defined in F.S. § 185.02, and one member shall be a firefighter as defined in F.S. § 175.032, respectively, elected by a majority of the active firefighters and police officers who are members of the plan. The fifth member shall be chosen by a majority of the previous four members as provided for herein, and such person's name shall be submitted to the legislative body of the city. Upon receipt of the fifth person's name, the legislative body of the city, shall, as a ministerial duty, appoint such person to the board of trustees as its fifth member. The fifth member shall have the same rights as each of the other four members appointed or elected as herein provided and may succeed himself in office. Each resident member shall serve as trustee for a period of ~~two~~ four years, unless sooner replaced by the legislative body of the city, at whose pleasure he shall serve, and may succeed himself as a trustee. Each police officer and firefighter member shall serve as trustee for a period of ~~two~~ four years unless he sooner leaves the employment of the city as a police officer or firefighter, whereupon the legislative body of the city shall choose his successor in the same manner as an original appointment. Each police officer or firefighter may succeed himself in office. The board of trustees shall meet at least quarterly each year. The board of trustees shall be a legal entity with, in addition to other powers and responsibilities contained herein, the power to bring and defend lawsuits of every kind, nature, and description. The trustees shall by a majority vote elect a chairman and a secretary. The secretary of the board shall keep a complete minute book of the actions, proceedings, or hearings of the board. The trustees shall not receive any compensation as such, but may receive expense and per diem as provided by law.

**Section 3.     Conflict/Repeal:**

All ordinances of Code provisions in conflict herewith are hereby repealed.

**Section 4.     Severability.** If any section, sentence, clause, phrase or provision of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining provisions of this Ordinance.

**Section 5.     Effective Date.** This Ordinance shall take effect immediately upon adoption by the City of Quincy, Florida.
