Approval of Agenda

amended agenda. Commissioner Brown seconded the motion. The vote was five to zero. The ayes were unanimous.

Special Presentations by Mayor or Commission

Letter of Commendation to Lieutenant Paul Mathews

Fire Chief Scott Haire presented to Lieutenant Mathews a letter of commendations for an act of bravery.

Lieutenant Paul Mathews Quincy Fire Department

QFD COMMENDATION FOR ACT OF BRAVERY

On June 20, 2015 Shift two was dispatched to a County structure fire with possible victim inside on Porter Mitchell Road at 8:37 in the morning. Upon arrival, Lieutenant Paul Mathews, Fire Fighter James Honderick and Fire Fighter Zach Fernandez found a single-family dwelling fully-involved in flame with partial roof collapse. Gadsden County Sheriff deputies were already on scene and waved the fire engine to the side of the house nearest the occupant of the house.

Lieutenant Mathews immediately made entry through the bedroom window, conducted a rapid search, and returned with the occupant, an 84 year old male subject. The occupant was turned over to Gadsden EMS for further medical treatment and transport.

Courage in the face of danger is an attribute all fire personnel must exhibit and Lieutenant Mathews has exhibited this attribute of courage throughout his career.

Lieutenant Paul Mathews I commend you for your efforts on June 30, 2015 in the rescue of this citizen from his burning home. Through your efforts and the efforts of your crew this citizen brought out to a point of safety outside the home

A copy of this commendation to be placed in the personnel files of Lieutenant Paul Mathews, Fire Fighter James Honderick, and Fire Fighter Zachary Fernandez.

Scott Haire, Fire Chief Quincy Fire Department

Mayor Elias presented to Lieutenant Paul Mathews a plaque and a medallion for his act of bravery on behalf of the City Commission.

Ms. Cynthia Hagins representative of New Bethel African Methodist Episcopal Church and on behalf of Pastor Charles Morris presented a check in the amount of \$250.00 to the Interim Police Chief Glenn Sapp to assist with the Quincy Police fund. Ms. Hagins thanked Chief Sapp for all he does in the community. Chief Sapp stated that the funds will go to Quincy Community Relief Fund which is a Christian based program that assist

transients. The program partners with churches to assist transient with a hotel stay with a one night stay at a hotel.

At a public hearing Commissioner McMillan made a motion to read Ordinance No. 1069-2015 by title only. Commissioner Brown seconded the motion. Upon roll call by the Clerk the ayes were Commissioners Brown, McMillan, Gay, Dowdell, and Elias. The Clerk read the title as follows:

AN ORDINANCE OF THE CITY OF QUINCY, FLORIDA, RELATING TO PARKS AND RECREATION; ENACTING RULES AND REGULATIONS FOR THE USE OF CITY PARKS AND RECREATION FACILITIES AS PART OF THE CODE OF ORDINANCES OF THE CITY OF QUINCY; PROVIDING FINDINGS; PROVIDING PURPOSE AND INTENT; ADOPTING SEC. 62-142, DEFINITIONS; ADOPTING SEC. 62-143 PURPOSE AND INTENT; ADOPTING SEC, SEC. 62-144, DESIGNATION OF HOURS OF OPERATION; ADOPTING SEC. SEC. 62-145, DESIGNATION OF AREA FOR PARTICULAR USES OR ACTIVITIES; ADOPTING SEC. 62-146, PROHIBITED ACTIVITIES IN PARKS AND RECREATION FACILITIES OWNED OR CONTROLLED BY THE CITY; ADOPTING SEC. 62-147, ALCOHOLIC BEVERAGES PROHIBITED IN PARKS AND RECREATION FACILITIES ADOPTING SEC. 62-148, ENFORCEMENT; ADOPTING SEC. 62-149, PENALTIES; ADOPTING SEC. 62-150, GROUP ACTIVITIES; PROVIDING FOR SEVERABILITY; PROVIDING FOR COPY ON FILE; AND PROVIDING AN EFFECTIVE DATE.

There were no comments from the audience.

Commissioner Dowdell had the following concerns: loiter in or near any structure designated for exclusive use by members of the opposite sex, seizure of property, permit shall be obtained before participating in a group activity composed of twenty or more persons, and how are we going to advertise these rules to the citizens. The Attorney stated that the designation would have to be tracked, the property would be seized for chronic violation of the rules, yes, a permit must be obtained and notification of the rules will be at the Parks and Recreation Department, at the Clerk's office.

Commissioner Gay stated we should maximize our facilities not limit the green space we can separate the green space with a fence not to impede the walking on the track field.

Commissioner McMillian made a motion to approve Ordinance No. 1069-2015 on first reading and schedule a second meeting for August 11, 2015. Commissioner Brown seconded the motion. Upon roll call by the Clerk the ayes were Commissioner Brown, McMillan, Gay, Dowdell, and Elias. Nay was none.

Fire Department on ISO Rating

Fire Chief Haire reported to the Commission that the Fire Department as of October 1, 2015 the City of Quincy's rating is improving from the current 5 rating to a new classification of 4 (the lower the number, the better the rating). He stated ISO will be evaluating the jurisdiction every five years. The rating is based on a number of factors including the City's water supply, capabilities of the City's Fire Department (equipment, staffing, training, response). The City of Quincy's overall score was 66.11. Commissioner McMillian asked what it would take to get a 3 rating. The Chief stated we need a training facility.

Cash Requirement

Mayor Elias asked how the bottom line compares to last year this time. Mr. Beason stated it is significantly less.

Commissioner Gay asked if we are currently under a payment agreement with SEPA. Mike Wade stated we have since paid that off. Commissioner Gay stated that Waste-Pro looks better. Commissioner Dowdell asked about vendor no. 146534 the shoe box, City Manager Mike Wade stated that the City provides a onetime per year purchase of work boots for public works and that is the vendor.

Financial Report - no comments

Budget Calendar

The City Manager presented to the Commission the FY 2015-2016 Budget Calendar the Commission made the following changes: August 4, 2015 Workshop on Electric Rates, Rate Stabilization and New Power Contract was changed to August 10, 2015. The August 18-20 Workshop was changed to August 24, 26 and 27, 2010. September 8, 2015 first public hearing to adopt proposed millage and budget was changed to September 9, 2015.

Other items requested to be agendaed by Commission Member(s), the City Manager and other City Officials

Comments

Emanuel Sapp of 821 2nd Street came before the Commission regarding the Manager's contract. He stated the City is getting a less qualified person to run the City and the citizens paid approximately \$10,000 for advertising to get someone to write grants to enhance the City, Mr. Wade was not part of the group the committee selected. We set aside our process and hired someone with less qualifications. One of the advertised persons was an African American. He stated that this is an atrocity for the City, he also stated that we are hurting that we have problem in Districts II and IV that the infrastructure is in need of repair. What grants do we have in Quincy now to anything. He stated we need someone with technical and educational skills. Mr. Sapp stated that he did not have anything against Mr. Wade.

City Manager

City Manager Mike Wade reported the following:

- Commend the Fire Depart for receiving an ISO rating of 4 the City is in the top 20% across the US for the rating.
- Martin Luther King Jr. Blvd paving plans are 98% complete and FDOT must approve the plans, we are on schedule. The Manager stated that he had a question with the stripping, do we want a turning land or leave it as is. Commissioner Dowdell stated that we should leave it as is.
- Public works cleaned the right-of-way at Crawford and Adams Street along Tanyard Creek, Brumby & 12th Street; in Shaw's Quarter Marshall and Chalk Streets right-of-way and the debris piles on Bradley were cleaned up; on Jackson and Sharon the asphalt were repaired; the property on Stanley Street was cut.
- He stated we are currently working on the Recreation and Public Works reports.
- A free football camp will be held Saturday, August 1, 2015 at Corry Field for ages 4-17 from 10:30 am until 2:30 pm, sponsored by Quincy Parks and Recreation and former players from FSU.

City Managers Contract

Mayor Elias asked the Commission if they had any concerns or questions with the contract. Commissioner Dowdell stated he don't have a problem with Mike you have done a fantastic job and he don't have a problem with the contract, he stated it was for political reasons that he voted at the last meeting to start negotiation with Mr. Wade to be on the prevailing side to bring the issue back up. Commissioner Dowdell stated we are putting the City in a bind and wants to be the first to say "we are setting ourselves up for a lawsuit." He stated that one of the applicants was an African American highly qualified. He stated that we had a citizen committee to review the applications and selected the top five and HR did not attend the meeting, he stated she was told by a Commissioner not to attend the meeting. A Commissioner can't give an employee direction that is against policy, we are not doing things by proper

procedure; we just hired Mike Wade who didn't apply for the position, he is voting against this because of the process we will be sued individually because we are not doing what we are elected to do we are going against policy. Commissioner Dowdell made a motion to reconsider the negotiations between the City Attorney and Mike Wade. The motion died for a lack of a second. Commissioner McMillian asked the Attorney if he saw anything wrong with our hiring process the City Commission sets the rules. The Attorney stated it is a highly discretionary process. Commissioner McMillan also asked I race was part of the employment application. The Attorney stated that it is not a factor. Commissioner Gay made a motion to approve the employment agreement between Mike Wade and the City of Quincy as City Manager. Commissioner McMillan seconded the motion. Upon roll call by the Clerk the ayes were Commissioners Brown, McMillan, Gay, and Elias. Nay was Commissioner Dowdell. The motion carried four to one.

City Clerk - none

City Attorney

City Attorney Scott Shirley informed the Commission that the federal district stated that you can't discriminate against religious institutions they must be treated in the same manner as other development. If additional questions are needed the Attorney requested that they be asked outside this meeting.

Commission Members

Commissioner Dowdell asked how that applies to the church. The Attorney stated we can't treat them any different than any other developer.

Commissioner Dowdell stated that there is a cone over a hole on Camilla Street. Commissioner Dowdell stated that water goes in the storm drain and goes back out the street always has water on the road during a heavy rain. City Manager Wade stated he did not know about the hole but will check on that. City Manager Wade stated that we have had a TV camera in to review what is going on, Public Works retrieved a lug wrench out of the pipe.

Commissioner Dowdell asked if the limbs had been trimmed at Hamilton and Virginia Street. The Manager stated it is on the schedule.

Commissioner Dowdell stated the limbs are on the line at Mr. Dantley's house and you can see fire on the lines.

Commissioner Dowdell reported that at Willie Ruth Williams Lane and Flagler Streets the limbs are hanging over the road way. If the trees are over the roadway we will take care of that.

Commissioner Dowdell stated that an elderly citizen on Inlet Street stated that the police was called out and the person ran through her fence and tore it down. He

asked does she need to file with our insurance company. The Manager stated he will get with her on that.

Commissioner Dowdell stated that Mr. Marshall was at the last meeting regarding the erosion behind his house he went behind his house and asked the Manager to meet with Mr. Marshall.

Commissioner Gay informed everyone that Florida Department of Transportation (FDOT) will hold a workshop Thursday at 5:30 pm at the National Guard Armory to discuss the second phase of the by-pass

Commissioner Gay asked Joe Monroe to come forward WTXL did a segment on Quincy. Joe Monroe of 313 North Jackson Street stated that he had just signed a lease at 5 North Madison Street for the Main Street Office and will plan a ribbon cutting ceremony and invite the City Commission and County Commissioners.

Commissioner Brown - None

Commissioner McMillan

Commissioner McMillan stated that the Police and Fire Pension Board, their Attorney Mr. Stebbins and Mr. Geiger are meeting to discuss allowing the officers to opt back into the plan. The Attorney will coordinate with the Manager. It is costing us \$116,000 this year.

Commissioner McMillan stated the Burmah Heights parks needs some attention ant bed and other growths.

Commissioner McMillan stated that the new contract for the Manger is 60% less than the previous Manager. That this itself speaks a lot of this Manager. He has done a heck of a job. He asked the Attorney was everything done legal. The Attorney stated yes.

The Manager stated the Actuary regarding the Police and Fire Pension will have a conference call via skype we will try and get that setup.

Jessie Marshall of 203 South Corry Street stated he appreciates Mr. Wade coming out to his property regarding the ditch. He was informed that the City has no immediate plans for the ditch.

Mayor Elias

Mayor Elias asked Mr. Beason if any of the Aid to Governmental Agencies had requested their funds. Mr. Beason stated no.

Mayor Elias asked the Manager to look into the City having a representative on the CRTA Board and asked Mr. Wade and Mr. Shirley to look into the matter.

Mayor Elias congratulated Mr. Wade on his appointment as City Manager.

City Attorney Shirley reported that due to some scheduling he will not be at the next meeting but Attorney John Rudolph will be present.

Commissioner McMillan made a motion to adjourn the meeting. Commissioner Gay seconded the motion. There being no further business to discuss the meeting was adjourned.

ORDINANCE NO. 1069-2015

A ORDINANCE OF THE CITY OF QUINCY, FLORIDA, RELATING TO PARKS AND RECREATION; ENACTING RULES AND REGULATIONS FOR THE USE OF CITY PARKS AND RECREATION FACILITIES AS PART OF THE CODE OF ORDINANCES OF THE CITY OF QUINCY: PROVIDING FINDINGS; PROVIDING PURPOSE AND INTENT: ADOPTING SEC. 62-142. **DEFINITIONS:** ADOPTING SEC. 62-143, PURPOSE AND INTENT: ADOPTING SEC. 62-144. DESIGNATION OF HOURS OF OPERATION; ADOPTING SEC. 62-145, DESIGNATION OF AREAS FOR PARTICULAR USES OR ACTIVITIES: ADOPTING SEC. 62-146, PROHIBITED ACTIVITIES IN PARKS AND RECREATION FACILITIES OWNED OR CONTROLLED BY THE CITY; ADOPTING SEC. 62-147, ALCOHOLIC BEVERAGES PROHIBITED IN PARKS AND RECREATION FACILITIES; ADOPTING SEC. 62-148, ENFORCEMENT; ADOPTING SEC. 62-149, PENALTIES; ADOPTING SEC. 62-150, **GROUP ACTIVITIES:** PROVIDING FOR SEVERABILITY: PROVIDING FOR COPY ON FILE; AND PROVIDING AN EFFECTIVE DATE.

SECTION 1. Findings.

WHEREAS, the City of Quincy is granted the authority, under Section 2(b), Article VIII, of the Constitution of the State of Florida, to exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, the City of Quincy, Florida, is the owner and operator of a system of parks and recreation facilities that are administered by the City for the use and enjoyment of the general public; and

WHEREAS, the City of Quincy City Commission has determined that it is in the public interest to assure the proper balance between the use of park facilities and the preservation of such facilities, law, and order; and

WHEREAS, the City of Quincy City Commission has determined that rules and regulations governing all parks and recreation facilities owned or controlled by the City are necessary in order to reduce property damage and closure of facilities due to vandalism; minimize the hazards of personal injury and loss of life; and maintain the quality of outdoor recreation resources; and

WHEREAS, the City Commission of the City of Quincy has further determined that the park rules and regulations enacted hereunder are necessary to promote and protect the public health, safety and welfare, and to ensure that use of these parks and recreation facilities and resources is consistent with good community morals and values.

NOW THEREFORE, BE IT ENACTED BY THE CITY OF QUINCY, FLORIDA, AS FOLLOWS:

SECTION 2. Purpose and Intent.

The purpose of this ordinance is to adopt rules and regulations governing all parks and recreation facilities owned or controlled by the City.

SECTION 3. Amendment of Code of Ordinances Chapter 62, Streets, Sidewalks and Other Public Places to add Sections 62-142 - 150.

Code of Ordinances Chapter 62, Streets, Sidewalks and Other Public Places is hereby amended to add Sections 62-142 through 62-150 as follows (<u>underline</u> type indicates additions, strikeout type indicates deletions, * * * indicates skipped language):

CITY OF QUINCY CODE OF ORDINANCES

CHAPTER 62 - STREETS, SIDEWALKS AND OTHER PUBLIC PLACES

ARTICLE VI. - PARKS AND RECREATION USE REGUALTIONS

Sec. 62-142. - Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

City parks or recreation facilities means all real properties owned or controlled by the City, regardless of the extent of development or official designation, which serve as picnic areas, recreation areas, nature areas, exercise facilities, athletic fields and such other areas, buildings or park facilities as are established or designated by the City for the use and enjoyment of the general public.

Handicapped person means any person who is developmentally disabled or mentally, physically or emotionally impaired as defined in F.S. § 760.22.

Park facilities means any improvements or structures, either natural or artificial, including, but not limited to, buildings, shelters, benches, tables, playground

equipment, walls, fences, fountains, walkways, toilet facilities, and signs located in, upon or around a City park.

Park grounds means the real property upon which parks are located, and any and all trees, shrubbery, flowers, leaves, grasses, plants, fruit, dirt, rocks, water, and bodies of water located above, on or under such property.

<u>Park personnel means all persons employed by the department of parks and recreation.</u>

Park roads means all surface areas either paved or unpaved which have been designated as routes for vehicular traffic. All other traffic ways are classified as a form of trail or path.

Parking areas means any designated part of any park or road or any area contiguous thereto which has been set apart for the stopping, standing or parking of any vehicle.

<u>Sidewalk means any area or way, whether paved or unpaved, which is set aside or open to the general public to accommodate pedestrian traffic.</u>

Vehicle means any device in, upon or by which a person or property is or may be transported on highways, streets or roadways; except that the term "vehicle" shall not include bicycles or electric or battery-powered toy cars.

Sec. 62-143. - Purpose and intent.

(a) In order to promote the public health, safety and welfare of the citizens of the City, a parks and recreation use regulations ordinance is hereby enacted for the general purpose of assuring the proper balance between the use of park facilities and the preservation of such facilities, law, and order.

(b) The intent of this article is to:

- (1) Reduce property damage and closure of facilities due to vandalism:
- (2) Minimize the hazards of personal injury and loss of life; and
- (3) Maintain the quality of outdoor recreation resources by establishing rules and regulations governing all parks and recreation facilities that are owned or controlled by the City.

Sec. 62-144. – Designation of hours of operation.

- (a) The City Manager, or designee, may designate the hours of operation for any City park and such designations shall be indicated on a schedule posted in the parks and recreation department of the City and filed with the City treasurer-clerk. The City Manager, or designee, may amend such hours of operation from time to time in a manner consistent with the purposes of this article, and may qualify such hours of operation to provide for after-hours uses such as for sporting activities or special events.
- (b) Where hours of operation are established, the City Manager, or designee, shall prepare, install, and maintain a sign or signs in each City park specifying the opening and closing hours of a particular park. Each sign shall be prominently displayed so as to give notice to the general public of the park's hours of operation.
- (c) It shall be unlawful for any person to enter or remain in any City park during such hours as the park is closed to public use.
- Sec. 62-145. Designation of areas for particular uses or activities.
- (a) The City Manager, or designee, may designate certain areas of a park or recreational facility for particular intended uses or activities such as, without limitation, picnicking, walking, jogging, or organized competitive sporting activities. Any park or recreational facility areas designated for particular uses or activities shall be included on a schedule posted in the parks and recreation department and filed with the City Clerk.
- (b) Where designated, the City Manager, or designee, shall prepare, install and maintain a sign or signs in each park where such use or activity areas are designated. Each sign shall be prominently displayed so as to give notice of the uses or activities for which the area is intended.
- (c) It shall be unlawful for any person to interfere with any other person engaging in a use or activity for which such area is designated.
- Sec. 62-146. Prohibited activities in parks and recreational facilities owned or controlled by the City.
- (a) Except for activities of a governmental agency within the scope of its governmental authority, or unless specifically permitted to do so by a permit issued pursuant to this article, it shall be unlawful for any person to do any one or more of the following in a park or recreational facility owned or controlled by the City:
 - (1) Sleep or protractedly lounge on the seats, or benches, or other areas.

- (2) Shave, shower, or bathe or otherwise be or remain in any water fountain, reservoir, lake, stream, pond, or other body of water located in any city park.
- (3) Shave, shower, or bathe in a public restroom or locker room; however, showering is permitted where shower facilities are specifically provided for public use.
- (4) Engage in loud, boisterous, threatening, abusive, insulting or indecent language, or engage in any disorderly conduct or behavior tending to a breach of the public peace.
- (5) Operate any audio device that can be heard by a person using normal hearing faculties, at a distance of one hundred (100) feet or more from the source of the sound, except for equipment used by law enforcement, City personnel or at City approved special group events.
- (6) Engage in any activity which is dangerous to the health, safety or welfare of another.
- (7) Engage in any activity which is not an activity allowed in such park, park area, or park facility, as such is indicated on a sign properly posted as provided in Sec. 62-145 above.
- (8) Build any hut, shanty, or shelter, or engage in any form of construction or digging, or related activity unless authorized in advance by the City Manager, or designee.
- (9) Erect signs, or distribute, display or affix signs on any tree, post, or park facility or grounds except signs posted by the director of parks and recreation pursuant to this article or posted in an area designated for such use.
- (10) Cook foodstuffs except in picnic areas where facilities for such preparations are provided by the City, or where cooking is otherwise authorized by the City Manager, or designee.
- (11) Set or stoke a fire, except where appropriate facilities are provided by the City.
- (12) Stop, stand or park any vehicle as defined in this article in an area not specifically designated for parking.
- (13) Operate any vehicle on park grounds in or on any area not specifically designated as park road, except in areas where such vehicle use is allowed or approved, or otherwise operate any vehicle in violation of the laws regulating traffic F.S. Ch. 316.

- (14) Allow any dog or other fur-bearing animal to enter or remain in any park unless within an area specifically designated for dogs and in compliance with rules posted for such activity.
- (15) Discharge or deposit human wastes except in toilet facilities provided by the City, or provided by a private party as part of an approved group activity.
- (16) Write on, draw on or otherwise deface, damage, remove or destroy any park property or facility or any other part of the park grounds.
- (17) Hunt, trap or pursue wildlife of any kind except as directed by the City Manager, or designee.
- (18) Discharge a firearm, air rifle, air gun, sling shot, bow and arrow, spear gun, or instrument of any kind that discharges or is capable of discharging a projectile by explosive means unless such instrument or device is required for participation in an activity which is organized or sponsored by the department of parks and recreation. Nothing herein shall be interpreted, applied or enforced in a manner which might constitute the regulation of firearms or ammunition, an area of regulation which is preempted to the State by F.S. §790.33.
- (19) Loiter in or near any structure or facility which is designated for exclusive use by members of the opposite sex.
- (20) Take into, dump or deposit in any park any trash or refuse of any kind; however, such refuse and trash as is generated during park or recreation area use may be disposed of properly by placing it in designated containers. Where such containers are not available, persons responsible for the refuse or trash shall remove it from the park for proper disposal elsewhere.
- (21) Using a park or recreation area for the purpose of benefitting, promoting, or furthering the interests of a criminal gang in violation of § 874.04.
- Sec. 62-147. Alcoholic beverages prohibited in parks and recreational facilities.
- (a) It shall be unlawful for any person to manufacture, possess, consume, purchase, sell or offer for sale any alcoholic beverage as defined in F.S. Ch. 561, or controlled substances as defined in F.S. §893.03, in any park or recreation facility which is controlled by the City except at the Tanyard Creek Amphitheater if authorized in rules adopted by resolution of the City Commission, or otherwise where authorized by the City Manager as a special event.

(b) It shall be unlawful for any person to enter any park or recreation facility intoxicated on alcohol or a controlled substance in a manner that endangers the safety of another person or property or causes a public disturbance in violation of F.S. §856.011.

Sec. 62-148. – Enforcement.

- (a) Ejectment. Law enforcement personnel and/or City park personnel shall have the authority to eject from the park any person acting in violation of this article.
- (b) Seizure of property. Law enforcement personnel and/or City park personnel shall have the authority to seize and confiscate any property, thing or device in the park used in violation of this article.

Sec. 62-149. - Penalty.

(a) Misdemeanor offense. Any person violating the provisions of this article is guilty of an offense and shall be punished by a fine not exceeding five hundred dollars (\$500.00) or imprisonment for a period not exceeding sixty (60) days or by both such fine and imprisonment. Each day a violation of this article continues is a separate offense.

(b) Civil Infraction.

- (1) Alternatively, a citation may be issued to any person violating the provisions of this article. In such circumstances, the violation shall be deemed a civil infraction.
- (2) Any person to whom a citation is issued shall pay the fine by the designated date or appear in county court at the time, date, and location designated in the citation. Any person requesting a hearing in county court waives the right to pay the minimum civil penalties. Penalties shall be in addition to court costs established by statute.
- (3) Minimum civil penalties for a violation not otherwise listed are as follows:

(i) First offense:	verbal or written warning
(ii) Second offense:	\$50.00
(iii) Third and subsequent offenses:	\$100.00
(iv) Fourth and subsequent offenses:	\$200.00

Sec. 62-150. – Group activities.

- (a) Permit. A permit shall be obtained from the City before participating in a group activity composed of twenty (20) or more persons, pursuant to the following:
 - (1) Application. A person seeking issuance of a permit hereunder shall file an application with the City's recreation department, which shall set forth information sufficient to determine whether such group activity will comply with the City's parks and recreation use regulations.
 - (2) Decision on Application. The City Manager, or designee, reserves the right to deny issuance of a permit for any group activity which, based on the available information, is likely to be unreasonably disruptive to the surrounding neighborhood or other park users, is too large for the park area or facility proposed for such activity, is disorderly or dangerous to persons or property, or is in any other way likely to be inconsistent with the City Parks and Recreation Use Regulations.
 - (3) Appeal. The City shall determine whether to issue the requested group permit within seven (7) days after receipt of an application. If the application is denied, the City Manager, or designee, shall inform the applicant in writing of the reasons for such denial of permit, and any aggrieved person shall have the right to appeal in writing within seven(7) days to the City Commission, which shall, at its next regular meeting, consider the application under the standards set forth in the City's parks and recreation use regulations and sustain or overrule the City Manager's, or designee's, decision within fourteen (14) days of the City Commission hearing. The decision of the City Commission shall be final.
- (b) Effect of permit. A permittee shall be bound by all park rules and regulations and all applicable ordinances fully as though the same were inserted in said permits.
- (c) Liability of permittee. The person or persons to whom a permit is issued shall be liable for any loss, damage or injury sustained by any person whatever by reason of the negligence of the person or persons to whom such permit shall have been issued.
- (d) Indemnification. The applicant and any other persons, organizations, firms or corporations on whose behalf the application is made, by filing a permit application, agree to obtain liability insurance coverage for the scheduled event, and stipulate that they will jointly and severally indemnify and hold the City harmless against all liability, including court costs and attorney's fees, and attorney's fees on appeal, for any and all claims for damage to property, or injury to or death of persons arising out of or resulting from the issuance of the permit or the conduct of the group activity or any of its participants.
- (e) Revocation. The City Manager shall have the authority to revoke a permit upon a finding of violation of any rule or ordinance, or upon other good cause shown.

- (f) Application form. The City Manager is authorized to prepare and utilize such application forms to permit group activities as are deemed necessary to effectuate the purposes of this section.
- (g) Fee Schedule. The City Manager is authorized to establish a schedule of fees for group activity permits issued hereunder.

SECTION 4. Severability

If any portion of this Ordinance is deemed by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then the remaining provisions and portions shall remain in full force and effect.

SECTION 5. Copy on File

A certified copy of this Ordinance shall be filed with the City Clerk of the City of Quincy.

SECTION 6. Effective Date

This Ordinance shall take effect upon passage.

<u>lssue:</u>

The City of Quincy does not currently have a Parks and Recreation use regulations ordinance in place. We feel that by enacting one, it will give us more clarity of the usage of our parks and recreation facilities and it will assist us in promoting the public health, safety, and welfare of the citizens of Quincy. We strongly feel that if this ordinance is enacted, it will assure us of the proper balance between the use of park facilities and the preservation of such facilities, law, and order.

Our overall intent is to:

- 1. Reduce property damage and closure of facilities due to vandalism
- 2. Minimize the hazards of personal injury and loss of life
- Maintain the quality of outdoor recreation resources by establishing rules and regulations governing all parks and recreation facilities that the City owns or controls.

Background:

We have noticed on several occasions and have received complaints and feedback from concerned citizens that some of our Parks and Recreation Facilities have been utilized for usages that they were not constructed for. There is evidence that people are conducting several inappropriate or improper acts in our parks and recreation facilities such as:

- 1. Bathing
- 2. Sleeping
- 3. Drug and alcohol usage
- Sexual activities

We have also taken complaints and feedback from concerned citizens that state that some activities that have taken place at our Parks and Recreation Facilities have impeded them from carrying out the activities in which the Parks and Recreation Facilities were constructed.

Some of these activities are:

- Playing soccer in the inside of our track field, which potentially could impede a
 person who is walking, jogging or running around the track and could possibly
 cause bodily harm and danger.
- 2. Racing remote controlled cars on our track field, which potentially could impede a person who is walking, jogging or running around the track and could possibly cause bodily harm and danger.
- 3. Playing kickball or softball in a kiddie playground area, which potentially could impede a person who is swinging, riding, climbing or jumping and could possibly cause bodily harm and danger.

We feel that we owe our citizens the highest quality of life that we can possibly give them; therefore we are recommending that you all approve the enactment of this ordinance.

Options:

- Option 1: Request that staff prepare the Parks Rules in ordinance format and bring the ordinance back to the City Commission for a public hearing on first reading
- Option 2: Schedule a workshop to discuss
- Option 3: Do not approve Parks and Recreation Regulations

Subject: Health Insurance for 2016

Pat Thomas Insurance Agency, our insurance broker, has informed us that if we stay with our current health insurance arrangement, the City will have a 16% increase. The City's annual health insurance cost

for employees will increase \$98,000 from \$647,000 to \$745,000.

Our current health insurance arrangement allows employees to choose between Capital Health Plan (HMO) and Blue Cross Blue Shield (PPO). Capital Health Plan rates are substantially lower than Blue Cross Blue Shield rates. In order to offer a PPO option to employees, the City agreed to blend the higher-cost Blue Cross Blue Shield with the lower-cost Capital Health. However, now facing a 16% increase, the staff recommends the Commission approve offering the Capital Health Plan only to the employees. Rather than experiencing an increase, the Capital Health Only option would result in a \$110,000 savings to the City and a \$23,000 savings to our employees who pay 25% of the premium.

While Blue Cross and Blue Shield rates for the employees were high, they have offered a Medicare supplement, Blue Medicare, for \$185 a month. The staff recommends that retirees over the age of 65 enroll in Medicare and then choose either Capital Health Medicare supplement or Blue Medicare. This change coupled with the lower rates with Capital Health for retirees who are not yet age 65, will save the City \$37,000 a year.

Option 1 For city employees, transition from offering both Blue Cross and Blue Shield and Capital

Health to just offering Capital Health. All retirees will enroll in Medicare at the age of 65, and choose between Blue Medicare and Capital Health. This is a total savings of

\$147,000 a year.

Option 2 Continue with Capital Health and Blue Cross Blue Shield as is, forego the \$147,000

savings and pay an additional \$98,000.

Subject: Police Electronic Control Device (Taser) Pilot Project

Issue:

The US Department of Justice and the National Institute of Justice have funded several studies to help law enforcement and corrections agencies make decisions to improve their policies and practices for using Electronic Control Devices/ECDs (Tasers). The study compared seven agencies that use ECDs with six agencies that do not. They found consistently strong effects for Tasers in increasing the safety of officers and suspects when the devices are used properly. The researchers also noted that officers can often deescalate a situation without using any force and should always use the least amount of force necessary.

Officers with the Quincy Police Department are in need of additional "less lethal" tools for their safety and safely dealing with dangerous and potentially deadly situations such as violent felons high on drugs such as methamphetamine, cocaine and molley. Less lethal options include the Taser device which would allow officers in limited policy regulated situations to safely detain or arrest a suspect who is actively resisting or assaulting the officer without having to resort to deadly force.

Background:

The Quincy Police Department has in its possession 6 ECD/Taser devices which were purchased years ago but were not issued.

Currently some of the law enforcement agencies in the immediate area that issue Tasers to all their officers include: The Gadsden County Sheriff Office, Gretna Police Dept, Havana Police Dept, Midway Police Dept, Tallahassee Police Dept, Leon County Sheriff Office, Florida Dept of Law Enforcement, Florida State University Police, and the FAMU Police Dept.

The Quincy Police Department is a professional full service police department. It services the City of Quincy which is the largest city and county seat in Gadsden County. We adhere to a professional Use of Force policies which recommends that officers make all efforts to not use this device on pregnant females, children, or the elderly. Officers can only apply a taser application to situations where the suspect is "Actively Resisting". It is at the active resistance level where officers and suspects are more likely to be injured creating expensive Workers Compensation situations for the city. This is a sample of the Use of Force Continuum which shows how officers escalate and de-escalate their use of force applications based on suspects:

Suspect resistance	Officer use of force
1. No resistance	1. Officer presence
2. Verbal noncompliance	2. Verbal commands
3. Passive resistance	3. Hands-on tactics, chemical spray
4. Active resistance	4. Intermediate weapons: baton, Taser, strikes, nondeadly force
5. Aggressive resistance	5. Intermediate weapons, intensified techniques, nondeadly force
6. Deadly-force resistance	6. Deadly force

We feel that Quincy Police Officers should be allowed every reasonable tool to protect themselves and others just as the majority of other police officers in Gadsden and Leon Counties. Officers will receive State approved training and be regulated and reminded of the great responsibility entrusted in them to only use this tool when absolutely necessary.

Option 1: Approve the requested implementation of a Pilot Electronic Control

Device/Taser Program.
