Statement of Issue:

This is the second reading of Ordinance Number 1074-2016 repealing Section 14-2 of the Quincy Code of Ordinances regarding tree removal permit requirement. Section 14-2 specifically requires that a permit be obtained prior to the removal of a tree that is more than 25 feet high. The first reading and public hearing on the repeal ordinance took place on January 12, 2016. Prior to that, on November 24, 2015, the City Commission discussed whether or not Section 14-2 should be repealed. It was concluded during that meeting that the requirement was not necessary and should be repealed. Thus, on January 12, 2016, the Commission voted unanimously to repeal Section 14-2 of the code.

There was a scrivener's error in the numbering of the ordinance in the original reading. During the first reading on January 12, 2016, the ordinance was presented as Ordinance Number 1073-2016; the Clerk later renumbered it to Ordinance Number 1074-2016. This second and final reading of Ordinance 1074-2016 will complete the process of repealing the requirement for tree permit (Section 14-2) from the code.

Options to Consider:

Option 1: Vote to repeal of Section 14-2 of Quincy Code requiring a permit

prior to the removal of a tree that is more than 25 feet high.

Option 2: Do not vote to repeal Section 14-2 of Quincy Code.

measures are required for the protection of life, limb and property. Such safety measures as he may reasonably require shall be complied with prior to, during and after the cutting down, sawing down, digging up or felling, as the case may be.

SECTION 4. Severability

If any portion of this ordinance is deemed by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then the remaining provisions and portions shall remain in full force and effect.

SECTION 5. Copy on File

A certified copy of this Ordinance shall be filed with the City Clerk of the City of Quincy.

SECTION 6. Effective Date

This Ordinance shall take effect upon passage.

Requirement for Tree Cutting Permit in the City of Quincy

Statement of Issue:

This agenda item is a follow-up to the request by a member of the City Commission during the last City Commission meeting that the code requirement for a permit, in order to cut a tree, be put on the agenda for discussion and reevaluation for possible removal from the code.

Background:

<u>Section 14-2:</u> In 1958, the City adopted into the code Section 14-2 requiring permit for the cutting of a tree that is over 25 feet in height. Paragraph (a) specifically states: "The cutting down, sawing down, digging up or otherwise felling of any tree which is more than 25 feet in height without first obtaining a permit to do so from the building official is prohibited." Paragraph (b) further states:

"Application for permit shall be made to the building official giving such information as he may reasonably require. The building official shall have a reasonable time after application is made within which to inspect such trees and the premises where such trees are located to determine what, if any, safety measures are required for the protection of life, limb and property. Such safety measures as he may reasonably require shall be complied with prior to, during and after the cutting down, sawing down, digging up or felling, as the case may be."

Staff Analysis:

The City's staff has evaluated the provision requiring that a permit be required prior to cutting a tree in the City of Quincy. It appears, from the phrasing of the provision, stated above, that the permit requirement was put in the code in 1958 as a means of reminding the person cutting a tree that the safety of life and property has to be ensured during the cutting of the tree. In the absence of the permitting process the City has no means of reminding the tree cutter of the importance of safety during the cutting of a tree.

<u>Permit Fee</u>: The fee for a tree cutting permit is \$100.00. According to the City's clerk, this fee of \$100.00 is not new; it has been in place since the 1990s. The application form includes a statement for the applicant to acknowledge that all work will be done in compliance with the applicable laws and "safety methods".

See attached Section 14-2 and the permit application form.

Conclusion and Recommendation:

As stated above, it appears that the requirement for the tree cutting permit was put in the code for safety reasons. However, these days, the cutting of trees is usually done by professional arborists (many of whom have insurance); thereby reducing the fear that the tree may not be cut safely. In light of this, it is probably appropriate to reassess the requirement and make some modifications to the code. One revision that could be made is to exempt residential properties and require permit for the cutting of trees on commercial properties since the landscaping and buffering requirements for a commercial property may include the retention of some trees on the property. Also, since the amount charged for the permit (\$100.00 per tree) appears to be the main complaint the City could choose to reduce the fee from \$100.00 to say, \$50.00.

Options to Consider:

Option 1:	Vote to modify the code to exempt residential properties from the
	tree cutting permit requirement and direct staff to come back with a

draft ordinance to that effect.

Option 2: Vote to leave unchanged the code requirement for a permit prior to

cutting a tree that is more than 25 feet high.

Option 3: Vote to remove from the code the requirement for a permit prior to

cutting a tree that is more than 25 feet high and direct staff to bring

back to the Commission a draft ordinance to that effect.

Option 4: Vote to leave the code unchanged and reduce the permit fee from

\$100.00 to \$50.00.



Subject: Return of FMPA Deposit

As part of our contract with the Florida Municipal Power Agency (FMPA) the City placed a \$1,000,000 deposit with FMPA. Since our contract has ended on December 31, 2015, the need for the deposit no longer exists and we have had discussion with FMPA staff about how the deposit will be returned.

As we continue to pay our remaining power bills with FMPA, the approximate time table for the return of deposit is as follows:

January 31 \$670,000 February 29 \$230,000 March 31 \$20,000 April 30 \$20,000 June 30 \$60,000

In keeping with our plans during the budget process, outlined below are the uses of the funds that will be returned to us.

- 1) \$338,824 Pay all outstanding vendor obligations OMI \$82,204, SEPA \$164,891, Waste Pro \$91,729.
- 2) \$175,000 Rate Stabilization to raise the checking account.
- 3) \$344,480 4 months of payments at \$86,120 to stock the 2003 and 2011 Debt Service Fund. Our yearly debt service payments are for these two bond issues are \$1,033,437.50
- 4) Aid in purchasing capital now -- backhoe 60,000 and Pole Truck 200,000.
